#### The Beginning of the MBSA

The MBSA was first formed in late 2014 when leaders from the Michigan Lumber & Building Materials Association (MLBMA) and the Indiana Lumber & Builders Supply Association (ILBSA) decided to come together under one group. The purpose was to provide a greater trade association experience for all members by creating economies of scale in headquarters and management, thus saving resources while improving critical programs.

The MBSA achieved legal recognition by the states in August 2015, and began its first operating/fiscal year on January 1, 2016.

Since then, the MBSA has been the home of building supply professionals in Indiana and Michigan, providing support for the industry through leadership, training and networking, while supplying financial, legal and operations assistance as well.
